## About the Parish Giving Scheme

Established in 2014, PGS has grown to support more than 5,000 churches by simplifying the giving process and enhancing financial stability. As of December 2024, PGS managed an income of around £100 million from more than 80,000 regular givers, reflecting significant growth and impact of its services to the local church.

At the Parish Giving Scheme, our vision is our guide for the future and everything we do today. # The Role of a PGS Trustee

**Overview**: Trustees oversee the governance, financial health and strategic direction of PGS, ensuring alignment with our charitable objectives and compliance with legal and regulatory requirements.

### Key Responsibilities:

- Attend and actively participate in quarterly Trustee meetings
- Provide strategic guidance and support to the management team
- Ensure the financial stability and accountability of PGS
- Act as an ambassador for PGS within your network
- Monitor risks and ensure effective management

**Time Commitment**: Approximately 3-5 hours per month, including attendance at quarterly Trustee meetings and occasional events.

Term of Appointment: Three years, renewable upon mutual agreement.

- Strong communication and interpersonal skills
